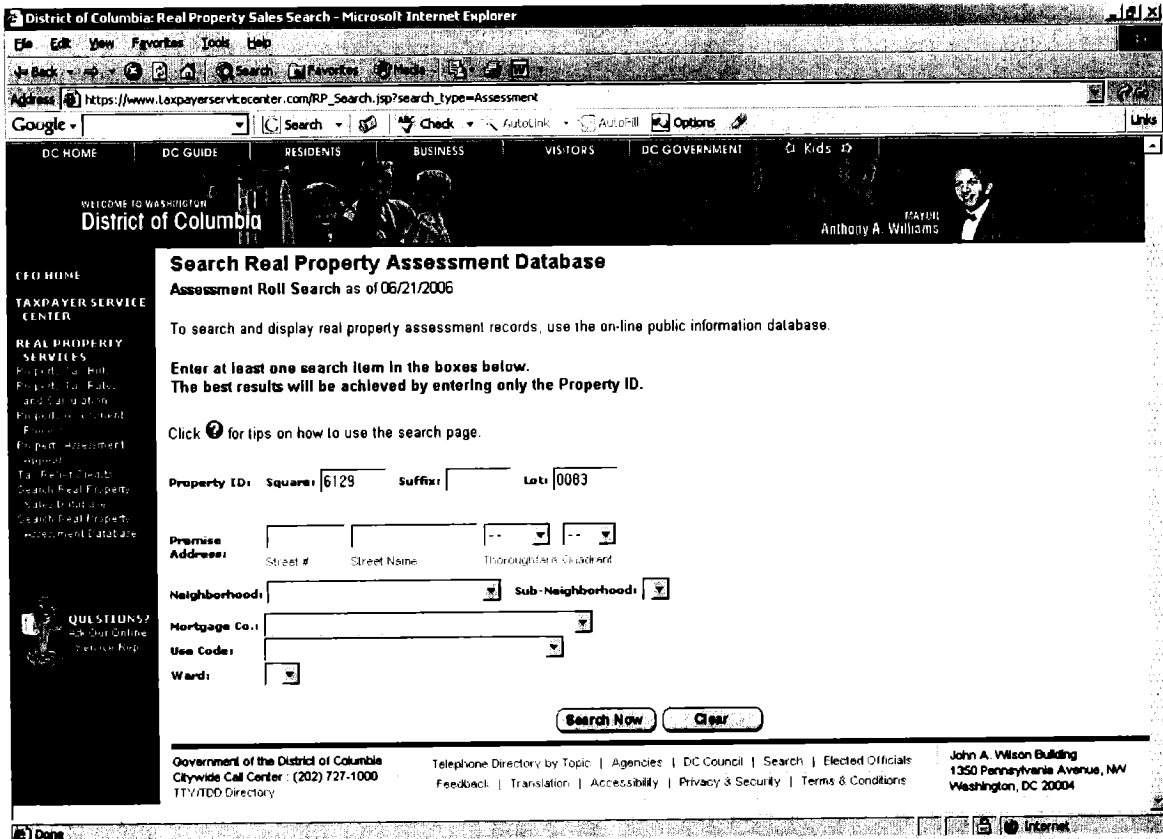

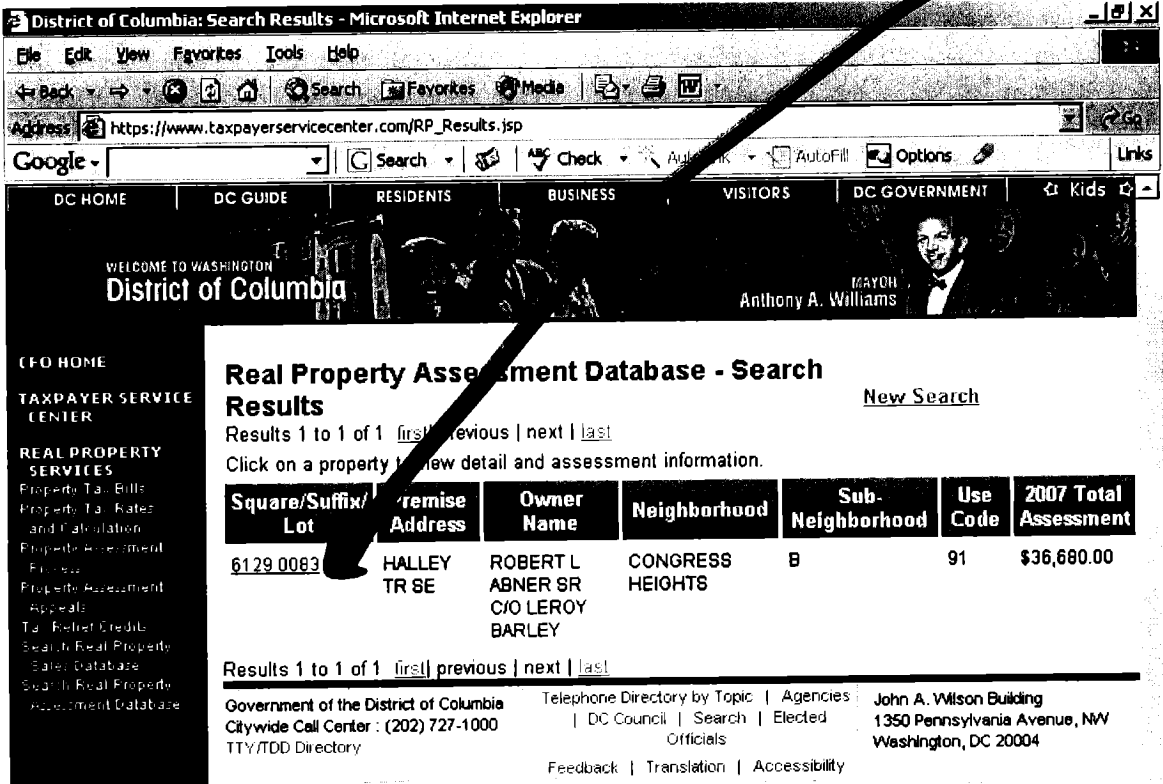

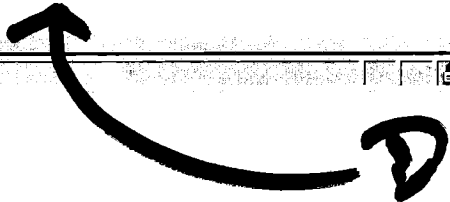
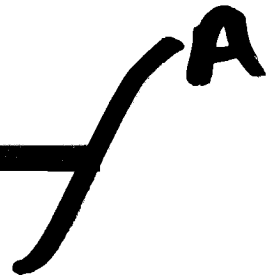


Figure 4: Fourth Screen of DC OTR Database
